
PERSONAL REPRESENTATIVES' DEED

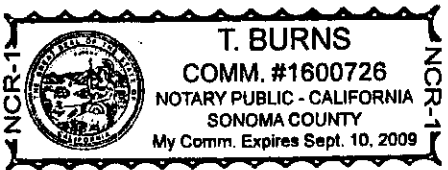

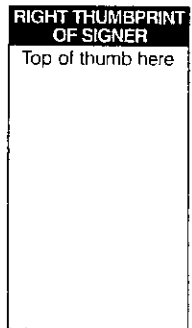

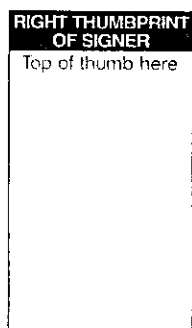
